A PERSON OR ENTITY THAT WOULD NOT GIVE RISE TO A CONFLICT OF INTEREST. IF A CONFLICT DOES OCCUR, THE BOARD OR COMMITTEE SHALL INFORM THE PERSON OF THE BASIS FOR SUCH BELIEF AND AFFORD THE MEMBER AN OPPORTUNITY TO EXPLAIN THE ALLEGED FAILURE TO DISCLOSE. IF THE BOARD OR COMMITTEE DETERMINES A CONFLICT OF INTEREST OCCURS, THEY SHALL TAKE APPROPRIATE DISCIPLINARY AND CORRECTIVE ACTION.
